Introduction

Pensacola State College (PSC), in collaboration with the University of West Florida (UWF) College of Business, has constructed a two plus two (2+2) articulation agreement in which PSC agrees to offer lower division courses leading to an Associate in Arts degree for transfer into the UWF Bachelor of Science in Business Administration in Accounting.

Program Goal

The Associate of Arts degree including the courses listed herein prepares students for transfer into the Bachelor of Science in Business Administration degree program in Accounting at UWF.

Agreement Provisions

- 1. Students will successfully complete the Associate in Arts degree at Pensacola State College including applicable requirements such as the Foreign Language Competency requirement and the Civic Literacy Competency requirement.
- 2. Students will successfully complete the Pensacola State College General Education requirements and are subject to the provisions of State Board of Education Rule 6A-10.030, College Level Communications and Computation Skills (often referred to as the "Gordon Rule"), which require completion of 12 semester hours of general education writing-emphasis coursework and six semester hours of general education mathematics coursework.
- 3. Pensacola State College will indicate completion of the Associate in Arts on the student's official transcript.
- 4. UWF will accept all courses from the Associate in Arts at PSC as indicated below in the course equivalency table.

5. Admission to UWF

The University of West Florida subscribes to the Florida Articulation Agreement for students who have earned an Associate in Arts degree from a Florida public institution.

6. UWF Graduation GPA Requirements

- a. A 2.0 cumulative GPA for all post-secondary institutions attended;
- b. A grade of C- or higher in all courses used to fulfil major requirements at UWF and a cumulative GPA in those courses of 2.50.
- c. No more than 24% of the program requirements may be in traditional business courses.

7. Immunization

Students who plan to take courses on the UWF campus are required to provide proof of Immunization in accordance with University Policy SA-12.04-06/16 Immunization Requirements.

8. Updates

This agreement is subject to change by legislative action, the State Board of Education, , the Florida College System, the Florida Board of Governors, the University of West Florida Board of Trustees, the Pensacola State College Board of Trustees, or external accrediting agencies. This agreement will be reviewed by both parties on a yearly basis to ensure the currency of this document.

9. Resources

Resources for the implementation of this agreement may come from either party, depending on budget availability. No party hereto is obligated to expend any resources whatsoever in connection with this agreement. No implementation of any portion of this agreement, or commencement of any specific projects, may be initiated prior to the written assurance of such budgetary availability to the other party hereto.

To the extent that any external funding is required by the University of West Florida in order to implement this agreement and funding for such purposes is not appropriated to the University of West Florida by the legislature of the State of Florida or is not otherwise available to the University of West Florida, the University of West Florida shall hence forth have no further financial obligations hereunder. In the event the University of West Florida does not have sufficient legislative appropriations to carry out any obligations under this agreement, it shall immediately notify Pensacola State College of such portions of this agreement that may be deemed terminated as a result of such failure of appropriations.

10. Statewide Articulation Agreement

This agreement is in compliance with the Statewide Articulation Agreement regarding the Statewide Common Course Numbering System rules on course equivalency.

11. Public Records

All parties shall allow public access to all documents, papers, letters, or other materials subject to the provisions of Chapter 119, Florida Statutes, and made or received in connection with this agreement. Refusal by either to allow such public access shall be grounds for unilateral cancellation of this agreement.

12. This articulated curriculum agreement shall continue for a period of five (5) years from the effective date of execution. The effective date of this agreement shall be determined from the date of the last signature. It will be automatically renewed for an additional one (1) year period unless either party provides the other written notice no later than sixty (60) days prior to the expiration of the preceding term that it wishes to terminate this agreement. If either party fails to follow the terms and conditions of the agreement as set forth therein, the other party has the right to terminate this agreement upon sixty (60) days written notice to the other.
