1. Tuition and fees are based on twelve (12) credits for average full-time enrollment X 2 semesters = twenty-four (24) credits. In-State Rate = \$120.89; Alabama Resident Rate = \$121.89; and Out-of-State Rate = \$486.49.
2. Books and supplies based on eight (8) books averaged at \$100 per book and \$150.00 for supplies per semester for full-time enrollment.
3. The average room and board budget for a student living with parents is calculated as \$300 a month for nine (9) months. The average room and board budget for students not living with parents is calculated as \$700 a month for room and board plus a \$150 for utilities to equal an estimated cost of \$850 a month for nine (9) months.
4. Transportation based on 30 miles round trip X 5 days per week X 32 weeks at .565 cents per mile.
5. Miscellaneous personal expenses based on estimated average expenses for personal hygiene items, clothing, recreation and entertainment.
