Introduction

Welcome to the Pensacola State College (PSC) Procurement Card Program. The procurement card (P-Card) is a payment tool. The Card allows departments to pay for certain transactions without submitting a requisition for issuing a purchase order or a voucher. Having a P-Card is a privilege that comes with responsibilities. This manual will serve as your guideline when using your P-Card. Whenever in doubt, you should always contact a P-Card Administrator. We are here to help you successfully utilize the P-Card Program.

The P-Card program intends to provide PSC and its departments with a streamlined payment method for department-related supplies and/or services. The P-Card is not tied to an individual's personal credit line. It is intended to be used by authorized staff for authorized purchases. It is NOT authorization to extend the department's purchasing ability to acquire items previously not authorized by policy or procedure.

The use of the P-Card is intended to achieve the following:

- Reduce the cost and volume of paperwork involved in processing routine transactions.
- Expedite the procurement process for authorized goods and services.
- Provide greater purchasing flexibility and empower departmental employees to manage expenditures.
- Shorten cycle time for ordering and receiving goods or services.
- Provide immediate payment by VISA to our suppliers, eliminating their invoicing the College.
- Improve accountability and control of small dollar purchases.

The P-Card Procedures & Guidelines Manual was created to provide instructions and guidelines for using the College P-Card. While this manual intends to provide a better understanding of the P-Card system, it is NOT intended to be all-inclusive or provide explicit instructions for every possible transaction that may occur within the organization. The manual provides a framework for forming a reasonable basis for processes and procedures. However, if further guidance is needed, the Purchasing Department or one of the program administrators is always available to help.

Acquiring a P-Card

- All College employees, designated by their Budget Manager, may be permitted to apply for a Procurement Card (Temporary, adjunct, and Kelly positions are not eligible to have p-cards).
- Complete the Request for P-Card in Workday (Attachment A.)
 - Provide a justification statement in the rationale field identifying the cardholder's need for a P-Card and planned usage (the types of charges expected to be made). Provide an average estimate of the highest monthly spend total anticipated for the Proposed Monthly Limit, along with an estimate for the highest single transaction anticipated for the Proposed Single Purchase Limit.
 - **If the requestor is not a Cost Center Manager**, then the request will be sent to the Manager of the Cost Center(s) in Workday, to which anticipated charges will be expensed for approval or denial of advanced spending authority. The Cost Center Manager will check the appropriate box to either approve or deny the requestor pre-approved, advance spending authority, or just spending authority that needs individual spend authorizations per transaction within Workday. (Multiple forms should be used when different managers need to authorize.)
 - If the Cost Center Manager grants the requestor advance spending authority, all applicable Cost Centers must be listed in the space provided. If the Cost Center Manager denies the requestor advance spending authority, the requestor, once issued a P-Card, will be required to submit a Spend Authorization via Workday for each anticipated P-Card transaction.
 - Spend Authorization approval will prompt the P-Card administrators to load the funds requested to the P-Card for purchase. Those p-card holders with their cost centers or pre-approved advance spend authority will always have funds loaded to their cards for spending in amounts concurrent to their budget and use history.
- The employee will be contacted when the procurement card is ready for pickup, and mandatory training will be set. At the time of pickup, the cardholder must sign the P-Card Agreement Form (See Attachment B). The Purchasing department will maintain the executed paper and electronic copies of all P-Card authorization and agreement forms.

Note: Although an individual's name appears on the P-Card, personal credit records will not be affected.

Activating the P-Card

- The cardholder can activate the card by calling the number on the card (1-888-339-2228).
- The ID for activation will be 5 zeros, followed by the last four digits of your Pensacola State College Employee ID number. For example, if you employee ID is 00501234, then the ID for activation is 000001234.

Maintaining the P-Card

- Spend limits (per transaction and month) will be based on the needs of the individual cardholder. Designated P-Card Administrators can look up and advise P-card holders of their single transaction monthly limits. Charges coded to a Cost Center Manager's Cost Center do not require prior authorization in the form of a spend authorization up to the spend limit indicated on the employee's P-Card Request Form. A Cost Center Manager can grant other supporting employees spending authority within their designated cost center. These employees can also spend up to a specific limit on their P-Cards without authorization approval as long as the purchases made apply to the employee's designated cost center. Spending limit changes can be made by submitting a P-Card Increase Authorization Form (See Attachment C).
- Spend authorizations, submitted via Workday, will be required for all charges coded to a Cost Center for which the cardholder is not the designated Cost Center Manager and has not been granted spending authority. In addition, all employees must submit spend authorizations for anticipated expenditures related to travel regardless of which Cost Center travel charges will be applied. The Spend Authorization encumbers an employee's travel and related expenditures to the College and initiates the Workday business process to ensure credit card charges are appropriately coded per cost center and spend category. Employees planning travel should also submit a Professional Leave absence to record their absence from regular job duties. Absence from the College where no expenses are paid should be recorded in Workday under the leave type of Zero\$TravelOFF. This leave type replaces the Zero Dollar Travel Authorizations completed by paper in the past.
- All P-Cards will be internally audited for usage. Areas to be monitored include, but are not limited to, compliance with Purchasing card regulations, designated spend limits, transaction details, the paying of fees for credit card use, and sales and use tax charges. Non-use of a card by cardholders will also be monitored monthly. Transaction and monthly spend limits will be adjusted according to need and use to minimize the risk of fraud.

Spend Authorization

An approved Spend Authorization serves as prior authorization of the purchase of goods and services to be charged to another Cost Center Manager's budget, a pre-authorization for travel, Fund 2 purchases or purchases for which Marketing (Printing or Advertising) or IT (equipment or software) approval is required. A Spend Authorization must be created, submitted, and approved via Workday before related charges are incurred for cardholders without spending authority or for individuals planning to travel. The Spend Authorization must include a description of the requested purchase and a justification statement explaining the necessity and benefit of the purchase to the College. The submitter must identify the appropriate Cost Center and Spend Category to which the purchase will be expensed and attach a quote outlining the total cost. Please note: For Fund 2, Grant-funded purchases, the submitter must identify the appropriate Grant Worktag in the space provided.

Once submitted, the Spend Authorization will go to the appropriate Cost Center Manager for approval. A P-Card Administrator will notify the cardholder when funds are approved and the P-Card is ready for usage.

Travel

All employees traveling at a cost to the College must use a Spend Authorization(s) to document approval in advance to travel in addition to submitting an absence request for the appropriate type of leave. The spend authorization will encumber the funds to prevent overspending when the travel does not occur right away. The employee must submit a Spend Authorization via Workday outlining estimated costs, even if the employee is the cost center manager of the funding source to be charged. P-Card allowable and prohibited purchases are listed below.

Rental Cars

If an employee requires a rental car for travel purposes, he or she should leverage the state contract, which offers discounted rates with Avis or Budget (the rental cost now includes the insurance coverage). The procedure to rent a vehicle for College use using the state contract is located on Piratenet (<http://piratenet.pensacolastate.edu/forms/>) under "Travel." Click [here](#) for the direct link to rent a vehicle for College use.

Zero \$ Travel Off

For travel without any cost associated, an employee must record hours worked off-campus via the "Time" or "Time Off" application in Workday. This has been set up for employees that are off campus working and replaces the hard copy "Zero Travel Request" form. The coding (i.e., Time Off Type: Zero\$TravelOFF) will record hours worked, and the employee will still receive their regular salary.

The figure below provides instructions on how to record off-campus work without any associated cost.

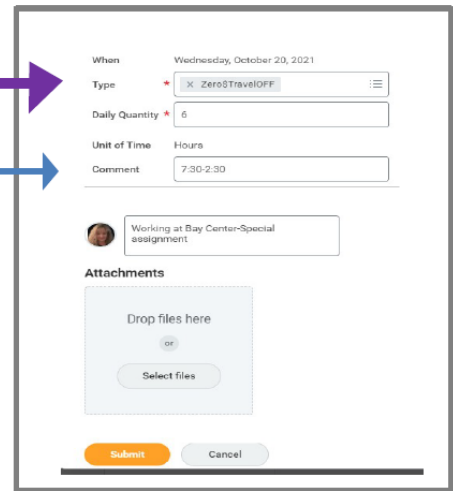
TIM 1010: Off Campus Work - Zero\$TravelOff

Employee

PURPOSE:

Recording hours worked off campus. This replaces the hard copy 'Zero Travel Request' form.

- Click on the Time or Time Off App.
- Click Request Time Off.
- On the calendar, select the day(s) you want.
 - To select multiple days, click on the dates. To unselect, click the date again.
- Click on the orange "Request Time Off" button in the bottom left corner.
- Select the Type of Time Off.
- Enter the number of hours you are requesting in the Daily Quantity field.
 - If requesting more than one day of off campus work, enter the hours for **one day** in the Daily Quantity field. Workday will calculate the total number of hours across the selected days.
- If requesting a portion of the day, in the first Comment field, enter the actual time (i.e. 7:30am – 12pm).
 - If requesting a full day, no time is needed in comment field.
- Click Submit.



Time Off Type: **Zero\$TravelOFF:**

Has been set up for employees that are off campus working. The coding will record hours worked and the employee will still receive their normal salary pay.

General P-Card Guidelines

P-Cards are generally used to purchase goods and services that do not otherwise fall under a College Requisition/Purchase Order and expenditures related to travel. Cost Center Managers will be assigned a monthly credit limit to make purchases using funds from their designated cost center(s) without prior authorization. Credit limits will be negotiated between designated P-Card Administrators and the Cost Center Manager based on the need and historical use of funds. Credit limit changes can be made by submitting a P-Card Increase Authorization Form (See Attachment C).

Use of the Credit Card shall be limited to the following conditions:

- a. The Cardholder will purchase items consistent with the Cardholder's organizational responsibilities and for the official use of PSC.
- b. Temporary increases to P-card spending limits may be made using the Temporary Increase Authorization form (Attachment C) in Workday.
- c. In instances where regular activity evidences itself to be lower than the amounts authorized for either single transaction limit or monthly limits, the cardholder or a P-Card administrator

may lower limits based on mutual consent. The cardholder can have the amounts raised at any time with just a phone call since they are authorized for more in their executed agreements. If the decline in activity amounts appears to be permanent and there is no reason to keep higher limits at the point of card renewal, the amounts will be adjusted to reflect the expected activity.

- d. The Cardholder **WILL NOT** split a purchase into multiple transactions to stay within the single purchase limit.

Emergency Use of Cards

P-Card Administrators will increase appropriate cards upon notification of an imminent emergency. For facilitated emergency expenditures, an increase authorization form with appropriate explanations and approvals should be routed to the P-Card Administrator within one week of the P-Card holder’s return to campus.

P-Card Cancellation

P-Cards are canceled for the following reasons:

- Cardholder misuse of the card.
- Cardholder terminates employment for any reason.
- Cardholder's job status changes where they no longer require a card.
- Cardholder reports the loss or theft of the card.
- Untimely submission of supporting documents.

If a card is canceled for any reason, it shall be returned to a designated P-Card Administrator.

P-Card Roles and Responsibilities

The Roles and Responsibilities of the P-Card Administrator, Cardholder, and Approver are crucial to the success of the P-Card Program.

P-CARD ADMINISTRATORS

P-Card Administrators are responsible for overseeing PSC's P-Card Program. The P-Card Administrator is a liaison between cardholders and PNC regarding card issues. The P-Card Administrator coordinates, monitors, and oversees the Card Program, ensuring that key controls are in place and are operating as designed. P-Card Administrators process P-Card Request forms for issue to College employees. P-Card Administrators also make periodic audits of card use and charges for appropriateness. Areas to be monitored include, but are not limited to, compliance with Purchasing Card regulations, designated spending limits, and sales and use tax charges. P-card administrators are responsible for ensuring the following:

- Performs audits including, but not limited to, credit and spend profile limits and supervisor authorizations.
- The P-Card Administrators can reduce credit limits or change spend profiles.
- Can at any time, suspend or revoke a P-Card for inappropriate usage, procedures not followed, or delay in responding to follow-up correspondence by the P-Card Administrators or Accounts Payable.
- Communicate with all cardholders and approvers regarding any changes, updates, or download changes affecting the P-Card process.
- Establishing and maintaining internal controls with the assistance of the Finance and Purchasing departments.
- Facilitating card dollar limitations and restrictions.
- Facilitating the issuance, replacement, and cancelation of all cards with the provider.
- Requiring all cardholders and approvers to complete P-Card training sessions and ensuring that the employees are informed of all the terms and conditions imposed with the privilege of using a card, including the dollar limitations and restrictions placed on their card.
- Reviews new account applications upon receipt.
- Reviews all procedures, guidelines, and forms used to determine if any need to be revised, enhanced, or updated.
- Deactivate P-Card upon request of the budget administrator or Human Resources.
- Works with Administration to identify and drive future program enhancements.
- Assists with problem resolution

P-CARD ACCOUNTING ADMINISTRATION

Accounting Administrators process Spend Authorizations and Expense Reports from all cardholders via Workday. Accounting Administrators monitor the availability of funds within the various Cost Centers and validate quotes when processing Spend Authorizations. When processing Expense Reports, Accounting Administrators review receipts for adherence to rules and ensure all required data and documentation are provided for auditing purposes.

CARDHOLDER RESPONSIBILITIES:

P-Card Pre-Authorization

- A cardholder intending to charge a purchase, or purchases, to a Cost Center for which they are not the Cost Center Manager is responsible for submitting a Spend Authorization via Workday ahead of the Expense Event to obtain approval before purchase. [Exception: If a Cost Center Manager grants a cardholder spending authority within his/her designated Cost Center, then the cardholder is not required to submit spend authorizations for purchases within that Cost Center. Cost Center Managers grant an employee spending authority via the employee's P-Card Request Form (See Attachment A), where the Cost Center Manager must identify the Cost Center(s) to which spending authority applies and provide a signature.] Submitting a Spend Authorization will prompt a budget check to ensure the funds requested are available. If there is insufficient budget to support a proposed purchase, the cardholder must work with their supervisor and the Business Affairs office to create a Budget Amendment that will render the requested funds available.
- Pre-authorization via a Spend Authorization is also required for travel, Fund 2 purchases or purchases for which Marketing (Printing or Advertising) or IT (equipment or software) approval is required
- For step-by-step instructions to complete a Spend Authorization in Workday, please refer to Attachment F.

Expense Report Review

- All cardholders are responsible for the timely reconciliation of P-Card expenses. A credit card transaction should be reconciled within five to ten business days after the date of purchase. Cardholders will create a new Expense Report via Workday to log and reconcile each new P-Card transaction. While all cardholders can create their own expense, cardholders can also delegate other employees, as appropriate, to create expense reports on the cardholder's behalf.
- It is the cardholder's responsibility to obtain receipts that specifically identify purchased items and other pertinent backup documentation. The College will use this information to validate and reconcile charges.
- Cardholders must obtain itemized documentation for each transaction. Documentation must include the supplier's name, date, unit cost, total cost, and an itemized description. The receipt amount must match the transaction amount in Workday.
- If the cardholder is unable to obtain or has lost their receipt, a missing receipt form must be completed in Workday. Once completed, an electronic copy of this form should be uploaded to the Expense Report in Workday.
- The written explanation may be used when a cardholder has exhausted all attempts to obtain a receipt from the merchant and must be attached to the reconciliation.
- Although credits can be processed without a receipt, an explanation of the credit must be attached to the reconciliation.
- The amount on the receipt and the charge in the card module must match. Any discrepancies in the amounts should be resolved with the merchant, and an explanation regarding the resolution should be made on the receipt or other backup documentation. It is not sufficient to change the amount on the receipt only. Upon reconciliation and approval, all original backup documentation shall be submitted as support to the transaction within Workday.
- For step-by-step instructions to create a new expense report in Workday, please refer to Attachment G.

Training

- Cardholder training is critical. It ensures that the cardholder understands the policies and procedures of the P-Card. All cardholders must complete training before they are issued a card.
- Once training is complete, the cardholder signs the cardholder agreement. The cardholder agreement validates that the cardholder has received training and a copy of the P-Card Manual. It confirms that the cardholder understands the policies and procedures of the card and is aware of potential disciplinary action due to abuse or misuse.

Compliance

- The cardholder and the Cost Center Manager are responsible for uploading all receipts to support transactions in Workday. Original receipts should be maintained for three months after the purchase date.
- The cardholder is responsible for turning in the old P-Card and applying for a new card if the cardholder changes departments or supervisors.
- The cardholder is responsible for any/all activity on their card. If a purchase is not valid, immediately notify PNC and the P-Card Administrators at pcards@pensacolastate.edu.
- The college is a tax-exempt institution and should not be charged tax except on out-of-state travel.
- P-card holders are not authorized to pay with credit card convenience fees without pre-approval from the VP of Business Affairs or the Comptroller.

Abuse, Fraud, Misuse & Lost or Stolen P-Cards

Personal Expense Charged in Error

The P-Card is to be used solely for authorized College purchases. Personal usage is not allowed with the card. If the P-Card is erroneously used to make a personal purchase, notify your Approver and the P-Card Administrator the following workday. Note “personal charge made in error” in the transaction description field and reimburse the College by making payment to the Bursar’s / Cashier’s Office. Funds should be returned to the same coding that the inappropriate charge is coded to so the two net to zero. Please include appropriate worktags to use for the deposit. Attach the receipt you received from the Cashier’s Office to demonstrate your reimbursement to the College.

Tax Exemption

The College is exempt from paying Florida state sales tax. Cardholders are given a Consumer's Certificate of Exemption Card to use as documentation. Purchases made in other states are subject to that state's sales tax. The cardholder must be diligent when dealing with the merchant regarding taxes. If the merchant cannot deduct the sales tax because of pre-set controls within their computer systems or will not honor the exemption, the cardholder may continue with the purchase but must note the refusal on the receipt.

Disputes and Erroneous Charges

If there is a problem with a purchase or transaction, the cardholder must first attempt to resolve directly with the merchant. In most cases, disputes between the cardholder and the merchant can be resolved.

The merchant will usually issue a credit. The cardholder should document all attempts to resolve any problem. If the item involves a reservation that has been canceled, the cardholder is responsible for obtaining a cancellation number. If efforts to resolve the issue with the merchant are unsuccessful or a credit does not appear on the card, the PNC dispute form must be filed (Attachment D).

All dispute notices must be filed with PNC **as soon as possible**. Notify the Program Administrator in writing of the dispute.

Reasons for disputes include, but are not limited to, the following:

- Unauthorized Charge-The cardholder did not make the purchase.
- Alteration of Charge Amount - The electronic transaction amount in the PNC Card software is different than the amount on the sales receipt.
- Disputed Transaction - The transaction took place, but there is a problem with the transaction, and the cardholder cannot resolve it with the merchant.
- Recurring Charge After Cancellation - A cardholder's account is charged although services were canceled within the cancellation period.
- Credit Not Received - The cardholder received a credit slip from a merchant, but the credit has not appeared in the P-Card software account within 30 calendar days from the date the credit was issued.

Fraud

Fraudulent activity is unauthorized use of the P-Card by the cardholder or a third party for non-college benefits. Help prevent P-Card fraud by storing your card in a secure area that can be locked. Never keep your P-Card in your purse or wallet in case it is lost or stolen. Ensure, when making online purchases, that you are using a secure payment website. Never share your P-Card information with anyone, including lending your P-Card to another employee. As a cardholder, you are responsible for all charges against the P-Card.

If you notice unauthorized charges on your P-Card, contact the PNC Fraud Department immediately at **1-800-685-4039**. PNC will need to discuss your recent history of transactions to determine if the charges are fraudulent. Next, email pcards@pensacolastate.edu stating that you have contacted PNC regarding your fraudulent charges. If fraud or suspected fraud occurs, PNC will cancel your current P-Card and order you a new card. Once the new card arrives, Business Affairs will contact you for pickup.

Misuse of P-Card:

If misuse or abuse of the P-Card is determined, the P-Card Administrators reserve the right to suspend or cancel the cardholder's P-Card, mandate additional training for the cardholder, notify the cardholder's supervisor and/or budget manager, or recommend disciplinary action up to and including termination of employment. To avoid such actions from occurring, please follow the policies and guidelines outlined in this manual. When in doubt if a purchase is authorized to make, please reach out to the P-Card Administrators at pcards@pensacolastate.edu to verify. Any unresolved misuse of a P-Card by unauthorized charges will be deducted from the employee's payroll check.

Stolen or Lost Cards:

Stolen or lost P-Cards must be reported immediately to the PNC Commercial Card Services Department

at **1-800-685-4039** and the P-Card administrators at pcards@pensacolastate.edu. PNC will automatically order you a new P-Card which will be mailed to the Business Affairs Office. You will be notified to pick up your new P-Card once it has been received and documented by the Business Affairs Office.

Frequently Asked Questions

1. Can I use my purchasing card for food/meals?

P-Cards should not be used for meals while traveling. Per diem meals are reimbursed directly to the employee once the associated expense report has been approved. Food purchases are limited by amounts budgeted for such. The ability to purchase food with College and grant funds is limited, so anyone without a specific budget for food should not buy it.

2. What is Unauthorized Credit Card Use?

Cardholders will not use the credit card for the following reasons unless specifically authorized in advance by the P-Card Administrator.

- a. Personal purchase or identification.
- b. A single purchase of supplies or equipment that exceeds the Cardholder's transaction limit.
- c. Postage stamps.
- d. Gift Cards (needs prior approval by VP Business Affairs or Comptroller).
- e. Personal Items (silk plants, pictures, area rugs, fans, and other items for office decoration/customization to personal tastes and preferences.).
- f. Purchase of services (Ex. repair or consultant services).
- g. Cash advances.
- h. Telephone calls.
- i. Cellular phones or service.
- j. Computers, printers, or other electronic technology devices.
- k. Employees whose responsibilities include purchasing meals are not to exceed the generally accepted level of gratuity (15%). Appropriate documentation must be provided if an establishment has a large group mandate of a higher gratuity.

3. What do I do if my credit card is declined at point-of-purchase?

You may call one of the P-Card Administrators listed below.

- a. Clark Puckett, 850-484-1793
- b. Craig Delseni, 850-484-1774

4. Under what circumstances might my card be declined?

Your card will be declined if:

- a. PNC has a security concern because of a use pattern (e.g., you haven't used the card for a long time).
- b. Necessary funds have not been loaded to your P-Card because either you have reached your spend limit as a Cost Center Manager, or a cardholder with spending authority to purchase items/services within a specific Cost Center, or the Spend Authorization submitted via Workday has not been fully vetted and approved. Please note: Once a Spend Authorization has been fully approved, the cardholder will receive notification from a P-Card Administrator via email saying the P-Card has been loaded with the requested funds for the purchase approved.
- c. Purchases exceed the amount authorized for a single transaction.

5. What do I do if I am charged tax?

If you are still at the place of purchase, show the vendor your tax-exempt card and ask the merchant to correct the charge. If you have left the place of purchase or if the merchant refuses to credit the tax, you may still make the purchase and pay the taxes. However, first contact the vendor and request they credit the taxes charged.

6. Will I encounter questions concerning the tax-free status of my purchases?

The sales tax exemption card should be sufficient identification to allow you to make tax-free purchases in Florida.

7. What would happen if I accidentally used my P-Card to make a personal purchase?

Personal charges should not be made with a P-Card; however, mistakes happen. Should this occur, itemize the personal charges as deductions to your reimbursement. If there is no reimbursement, or the personal charge exceeds the reimbursement request for travel or direct purchase, you must proceed immediately to the Cashier's Office, pay for the personal charges, and submit this receipt (personal charges highlighted) with other receipts. Misuse of the card could result in the card being canceled.

8. What do I do if a charge shows that I (the cardholder) did not make?

You should call the merchant to request that the vendor provide you with the details of the charge. If you did not make the charge and cannot resolve the problem with the merchant, contact PNC using the appropriate telephone number listed on the back of the credit card to dispute the charge, as you would with your personal credit card.

9. Where can the P-Card be used?

The card can be used anywhere VISA is accepted.

10. Will the Purchasing Card transaction appear on departmental ledgers?

Yes. P-Card payment amounts will reflect on departmental budgets as direct disbursements, and card refunds/credits will reduce disbursements in the accounts indicated on the Spend Authorization.

11. When submitting a Spend Authorization for travel, what expenses must be included in the authorization request, and what documents must I attach?

Typically, the requestor must provide estimates for either airfare or rental car (depending on the method of travel), mileage (if using a rental car), hotel fees, and per diem. Attachments should include applicable estimates for airfare, rental car, computer-generated directions to and from all applicable locations to account for mileage, hotel estimate, and itinerary/conference agenda to justify per diem estimate.

Definitions

Approvers: The individual who is responsible for approving each transaction by the cardholder in their hierarchy.

Authorized Purchases: Purchases and expenditures made by a cardholder on behalf of the College allowed by law, policy, and procedure within the approved budget authority.

Budget Manager: The PSC College personnel who oversees the departmental budget and authorizes employees to spend money from a particular department as outlined in the Chart of Accounts.

Budget Review: The responsibility of the P-Card holder is to review the budget and ensure funds are available **prior to** buying goods or services on the P-Card and again upon reconciliation of P-Card charges.

Budget Transfer: Completed by the Budget Manager in coordination with the Budget Office to move funds from one account to another within a department. Transfers may be needed before the P-Card is reconciled to maintain proper accounting.

Cardholder: PSC College employee whose name is engraved on the P-Card and who is responsible for all transactions associated with their card. Responsible for the (electronic – preferable) storage of all transactions for easy accessibility for the time period of three months.

Cardholder Application and Agreement: Agreement signed by the cardholder, reconciler, approver, budget manager, and VP of Business Affairs. Signifies that the cardholder has completed the required P-Card training and acknowledges by their signature that they are aware of the procedures and guidelines governing the use of the Procurement Card.

College Purpose: The College purpose statement must be included as part of the description provided when reconciling the P-Card transactions. The statement should answer the five questions “**who**” is the vendor, “**what**” was purchased, “**when**” was it purchased, “**where**” department/campus purchase was made for, and “**why**” College business purpose or benefit to the College.

Consultant: One who gives professional advice or provides a service. Requires a [Consultant Agreement](#) to include the scope of work (SOW) and payment. Payment by a P-Card is **not** permitted for this type of expenditure (APM 05-0801).

Disputed Item: Any transaction that was not authorized by the individual cardholder.

Documentation: Proof of purchases made with the P-Card, which includes, but is not limited to: detailed cash register receipt, invoice, receiving report, packing slip, copy of order form, confirmation slip, and/or procurement card charge slip, as long as an itemized description, unit cost, total, supplier or name, and date is listed. The receipt must match the total of the transaction in Workday. Other required documentation (if applicable) are agenda items, attendee listing, student list, flyer, and college purpose (who, what, when, where, and why). If none of the documentation mentioned is provided, the cardholder must complete a **PSC Missing Receipt Form** found on Piratenet (insert link).

Fraud (Fraudulent): Intentional misuse of the college credit card.

Goods: Material, supplies, commodities, printing, small-dollar items, and any other articles or items used by a spending unit.

International Supplier/Merchant: A supplier (vendor/merchant) that's business resides outside the United States. A P-Card can be used for these items as long as the goods/services follow College policy and as outlined in this Procedures & Guidelines Manual.

Inventoried equipment/furniture (tangible assets): Any item \$5,000 or more that will be tagged by Property Management or any IT equipment, regardless of cost.

Itemized: A detailed list of goods/services purchased with the unit cost and total.

Monthly Credit Limit: The budget administrator and VP of Business Affairs approve the monthly credit limit via the application and card agreement forms. Credit limit changes can be made by submitting a [P-Card Increase Authorization Form \(See Attachment C\)](#) that requires approval from the cost center manager and VP of Business Affairs. PSC's Increase Authorization Form can be found on Piratenet at the following link:

Personal Items: Using the P-Card for personal expenditures is strictly prohibited. Cardholders who violate this rule must reimburse these funds to the College and, if the violation is determined to be intentional, may be subject to both loss of employment and criminal penalties.

Personal Reward Cards: Any card or reward given to an individual while using the College's P-Card. Examples include, but are not limited to, Staples Rewards, Airfare mileage, Bonus Cash on your next purchase, etc. Personal rewards are **not** permitted using College funds.

Procurement Card or P-Card: Credit card issued by the Procurement Card Provider in the name of PSC to an individual cardholder. PSC currently utilizes the VISA credit card.

Processing Fee: A fee attached to a supplier (vendor) transaction because of the fee assessed by their bank institution. It is strongly recommended that any supplier/vendor who charges a processing fee not be used on the P-Card, pursuant to *Florida Statute 501.0117*. A Requisition should be created to avoid paying additional funds.

Reconciliation: The process within Workday where the cardholder's transactions are uploaded to assign the proper chart of accounts and attach required documentation. The reconciliation process confirms that the P-Card holder has received the goods ordered upon approving the items. The College purpose must be included in the description when reconciling the P-Card charges. Detailed instruction on how to properly reconcile your P-Card is provided in the P-Card training.

Restricted Purchase: Purchases made not following College Policy or as outlined in this Guidelines Manual.

Spend Profile: Includes credit limit and special authorizations, such as hospitality/food items, IT items, and entertainment.

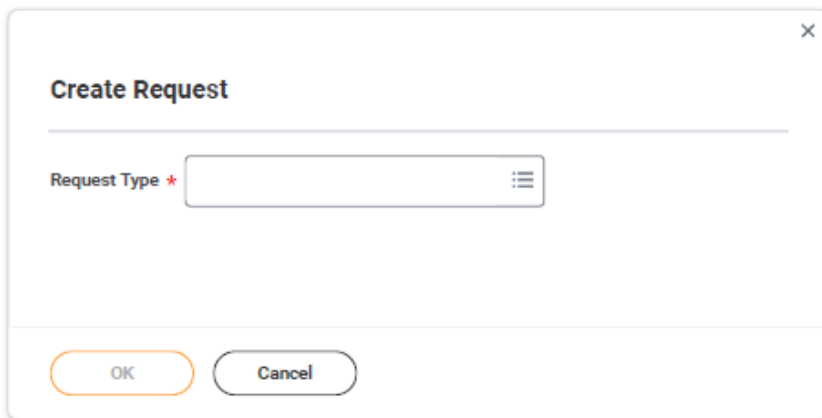
Tax: The College is Tax Exempt and should not be charged taxes by any Florida-owned business.

Temporary Employee: Any person who is not a PSC employee. Staff hired by companies such as Kelly. Temporary employees cannot be P-card holders.



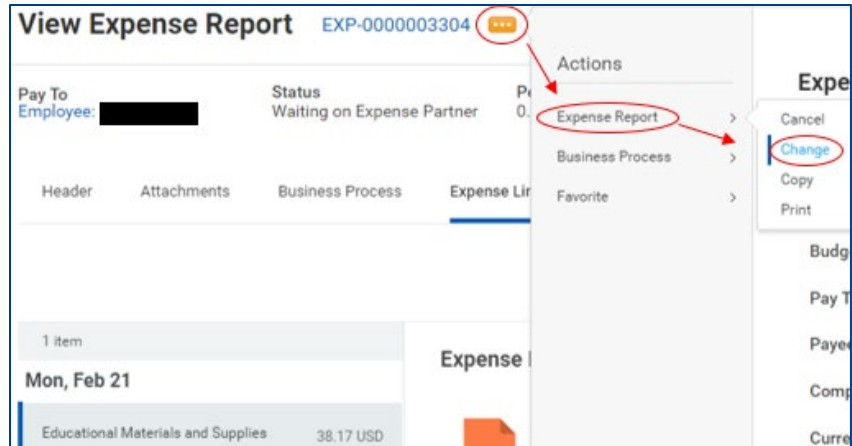
Editing an Existing Expense Report

During the review and approval process, if a P-Card administrator or Budget Manager determines data is missing from an Expense Report and/or needs revision, the reviewer will send the report back to the cardholder explaining the edits required prior to re-submission. The instructions below enable the cardholder to reopen and edit an existing Expense Report.

1. To edit your Expense Report, type the Expense Report number (e.g., EXP-0000003185) in the search bar and hit Enter. Click on the blue URL of the Expense Report number in the next window. (Tip: If your search does not produce results, then navigate to the list of WD options on the left side of the screen, scroll to the bottom of the list, and click “All of Workday.” The blue URL for the Expense Report you are searching for should now appear.)



2. On the next screen, hover over the three dots (commonly referred to as the ‘carrot’ given their orange hue when selected) next to the EXP #. Click the carrot, hover over ‘Expense Report,’ and under ‘Actions’ click “Edit” or “Change.”




3. Click the 'OK' button that then appears at the bottom left side of the window. You are now in Edit mode.
4. To connect an Expense Report to a Spend Authorization:
 - a. Navigate to the Header Tab and click the "Edit" button in the bottom left corner of the window.
 - b. Next to "Spend Authorization," click on the drop-down icon and select the appropriate Spend Authorization by referring to the associated dollar value.
 - c. Check the box to the right of "Final Expense Report," then click Save.


