# Quizzes – (Weekly & based on assigned readings / lectures) – (25%)

Students are required and assigned to complete one 'chapter' quiz each week that will be administered through our online Canvas course that is linked to this in-person ARH 2000 – Humanities Art course, section, and the assigned open-source text. This weekly assignment will cover lectures, readings, videos, discussion(s) and the cumulative online quiz for the individually assigned 'chapter', which is due at the culmination of each meeting session / week, unless otherwise designated by the instructor. The Canvas Modules are not subject to change and student must maintain the overall scheduled pace of the course. Late work will receive an overall deduction in the potential grade at the discretion of the instructor. Any proposed deadline extension must be approved by the instructor prior to the assignment due date.

# <u>Critical Review Response(s) – (25%)</u>

Students are required to submit one Critical Review Response statement regarding the provided prompt each week that outlines their newly learned information, content, and concepts. Students must provide their own created content based upon the assigned readings, discussions, and other coursework throughout the course.

# Daily Discussion Board – (25%)

Each week you will be required to participate in class discussions. Students are required to contribute to the Daily Discussion each week that is directly connected to the content covered in that assigned Module(s). The Daily Discussion(s) must remain aligned with the assigned weekly chapter readings and content, but should also reflect the individual student's personal experiences, perspectives, associations, opinions and thoughts related to this content. The student's goal is to establish a thoughtful and considered link to the Module(s) content and its relatability to contemporary society. Students should also provide mindful and measured judgement when contributing to the required engagement with their peers each week.

During our in-class Daily Discussion, please engage with at least ONE peer with thoughtful and connected feedback. To receive full credit, you are required to engage with in our thoughtful group discussion by communicating your 'takeaway' with TWO peers in the Daily Discussion before the end of the scheduled course meeting session.

#### Active Engagement – (15%)

Students are required to be on-time, actively engaged and contribute to the course in its entirety. Attendance will be taken and enforced at the beginning and end of each course meeting session and students will receive full credit for this assessment by remaining present in all facets of the word itself.

# Final Exam - (10%)

The Final Exam will be fully comprehensive to the ARH 2000 – Humanities Art course. The exam is based on the weekly quizzes and course content. No late submissions of the Final Exam for the course will be accepted.

In this course, students will develop an appreciation of and the ability to think critically about culture and be provided with the tools to understand, analyze, and discuss works of visual art and material culture.

- 2. Students will apply terms, concepts, and methods used in the discipline of art history to works of visual art and material culture.
- 3. Students will identify and describe works of visual art and material culture in the works' cultural context, including works from or inspired by the western canon and other cultural traditions.
- 4. Students will analyze works of visual art and material culture in the works' cultural context, including works from or inspired by the western canon and other cultural traditions.
- 5. Students will generate an analytical response to works of visual art and material culture in the works' cultural context.
- 6. Identify and explain the different forms of artistic expression connected through different times and cultures.
- 7. Express humanistic concepts and express knowledge of artistic expression and the influence of time and culture.
- 8. Demonstrate a familiarity with cultural diversity in artistic expression.
- 9. Compare and contrast various works of art as they span through different eras, cultures, and locations.
- 10. Explain the difference of works of art ranging from the ancient world to contemporary art.

#### **Attendance / Tardiness / Withdrawal:**

Students are required to attend and actively engage in the course each week and maintain an appropriate amount of participation in the presented materials and discussions. Being present, alert, contributive, and involved in the coursework is required and not limited to any individual course meeting format. The following attendance policy has been implemented in the best interest of the student and is in accordance with the PSC Attendance Policy detailed in the Student Handbook.

Class participation is an important part of the learning process and is therefore expected of each student. You

must participate; read and respond to daily discussions, review the lecture notes and PowerPoints, participate in the practice activities, check your course email, etc.

Students are permitted a total of (3) absences in this course before overall grade deductions will be enforced. A student with a (4<sup>th</sup>) absence and beyond, will drop by one letter grade per absence(s). Meaning, a (4<sup>th</sup>) absence will result in the highest overall course grade being a 'B', and (5<sup>th</sup>) absence resulting in a 'C', and (6<sup>th</sup>) resulting in a 'D' and if a (7<sup>th</sup>) absence occurs, the overall grade for the course is a 'F' or failure. Students that are late by more than (10) minutes to the required meeting pattern will be counted towards the overall absence policy whereas two late arrivals are the equivalent of one absence. This too reflects the overall scoring for the course.
