**Course Description:** A study of the American federal system of government with emphasis on the constitutional distribution of powers among the legislative, executive, and judicial branches and the states. An analysis of policy formation as related to democratic theory and the role of government in the society.

# **Special Requirements:**

Writing Emphasis Requirement: A minimum of three fully developed, multi-paragraph, evaluated writing assignments, not including a final examination, are required.

Writing Emphasis Requirement: Instructors provide detailed feedback regarding the content, organization, and use of standard written English for each evaluated writing assignment.

Writing Emphasis Requirement: Instructors return each evaluated writing assignment to a student before submission of the next evaluated writing assignment.

Writing Emphasis Requirement: Only individual student work may count toward the minimum three evaluated writing assignments.

Writing Emphasis Requirement: Grading rubrics will be used for each evaluated writing assignment. These rubrics will be shared with each student.

Writing Emphasis Requirement: The grades earned on the writing assignments must reflect student performance in college-level writing and significantly impact the final course grade.

Evaluations of student progress towards achieving the stated learning outcomes and performance objectives is the responsibility of the instructor, within the policies of the College and the department. Detailed explanations are included in the course supplementals developed by the instructor for each section being taught.

[Exams: There will be three exams (see course schedule below). Exam three will take place during Finals week and will be cumulative.

Written assignments: You will be submitting 3 written assignments throughout the semester (the due dates for each are noted in the semester schedule), each covering major themes and issues covered in the textbook and the classroom. One of these writing assignments may be a group/collaborative project. You will be issued topics/prompts at least one week before each writing assignment is due. Length will range from 2 - 4 pages (although I reserve the right to use word count instead), double spaced, 12 point font.

Turnitin: Your writing assignments will be submitted via Turnitin. Some of you might be familiar with this program. Turnitin is used as a plagiarism checker. If you submit drafts of your papers BEFORE they are due, you will have the opportunity to revise areas of your paper where you might be unintentionally plagiarizing

sources and/or not citing them correctly. We will discuss this further in class before the due date of your first written assignment.

Participation: Your participation in this exercise counts for 20 percent of your total grade. Your participation grade will be evaluated by your attendance, participation in our classroom discussions, and occasional participation exercises. I will discuss this further in the first week of the course.

At the end of the semester, I will forgive TWO missed classes for each student. A note on attendance: "Participate in class. You are paying for it. More importantly, you are here to learn, aren't you? There is no substitute for classroom interaction." (imagine me saying this to you out loud)

I've been an instructor long enough to know when you are taking notes and when you are checking the sports scores and socials. Also, I can see the phone hidden behind your book or on your lap. Don't test me. Lastly, this class is not a study hall for your other classes.

Yes, I know this class is online, and some of these policies may not translate directly to online class. However, these principles serve as very good advice for all students, and I include it herein to help you learn good classroom habits.

While email is the best method for contacting me, be reasonable in your expectations of response times. I check my email multiple times a day and generally can respond within 24 hours rather than 24 minutes. Also, I am unlikely to respond to emails from 9pm – 8am. Lastly, instructors are people too and need time to recuperate from the week. As such, I will not respond to any emails on Sundays. Lastly, please email me with your assigned PSC email and make sure I know what class you are taking. Non-university assigned email addresses have a way of ending up in spam folders that I do not check on a regular basis. As a side note, if you're still rocking the "rolltide2023@hotmail" or "queen of tictok32@gmail" email address, it is time to upgrade to something more professional!

Additional Information on Plagiarism:

I reserve the right to submit written assignments to the Turnitin service or use other methods to evaluate the originality of the work submitted. I will remove personal identifiers from any electronic files I submit to the Turnitin database for evaluation.

Plagiarism is a serious violation of academic standards and will be punished severely. Students who plagiarize will fail the course and will be referred to the Dean for academic dishonesty. Some students are surprised to learn that they plagiarized themselves when they inappropriately used work produced for one course in another course. If you are unsure, ask your instructor for guidance. You may feel the urge to plagiarize. Don't do it. You will be caught, and you will be punished severely. I have testified at several academic misconduct proceedings. To a person, the perpetrator regrets his/her/their decision. Punishments vary, don't gamble with your academic career. These are short papers, do the work. Your paper will go through a plagiarism checker, so DON'T CUT AND PASTE from an online source.

If I suspect AI was used as the primary source for your work, you will be required to complete additional in-class verification of knowledge to ensure that are satisfying the desired outcomes for this class. This may be accomplished by written or discussion-based inquiry, at instructor's preference.

Extensions: Generally I do not allow extensions except in the most extenuating of circumstances. Lack of planning, lack of preparation, or unexpected illnesses or personal issues do not constitute extenuating circumstances. Despite this warning, if you feel you both need AND deserve an extension to an assignment deadline, you must do so during posted office hours (for face to face classes) or via live Zoom meeting (for online classes). I will not entertain requests via Canvas message, email, telegraph, messenger pigeon, smokesignal, courier, or in the classroom.
