**Course Description:** A survey of psychology as a social science. Covers the biological and social determinants of human cognition, emotion, and behavior. Attention will also be given to the history of the discipline, forms of psychopathology, and the growing role of brain science within the field.

**Special Requirements:**

*Writing Emphasis Requirement:* A minimum of three fully developed, multi-paragraph, evaluated writing assignments, not including a final examination, are required.

*Writing Emphasis Requirement:* Instructors provide detailed feedback regarding the content, organization, and use of standard written English for each evaluated writing assignment.

*Writing Emphasis Requirement:* Instructors return each evaluated writing assignment to a student before submission of the next evaluated writing assignment.

*Writing Emphasis Requirement:* Only individual student work may count toward the minimum three evaluated writing assignments.

*Writing Emphasis Requirement:* Grading rubrics will be used for each evaluated writing assignment. These rubrics will be shared with each student.

*Writing Emphasis Requirement:* The grades earned on the writing assignments must reflect student performance in college-level writing and significantly impact the final course grade.

### **Methods of Evaluation:**

At minimum, the instructor will cover content which aligns with statewide and institutional learning outcomes for the course. The instructor will measure student performance using the following:

## Exams

Only two exams will be administered throughout the semester, a midterm and a final exam. Both will be timed exams comprised of multiple-choice, multiple answer, matching, and/or true/false items. All assessments, including the exams, will be administered through the Canvas course site. Unlike other assignments, exams will be proctored using the Proctorio app. **ANY AND ALL MATERIALS (E.G. TEXTBOOK, NOTES, ETC.) OR OUTSIDE ASSISTANCE ARE EXPRESSLY PROHIBITED DURING EXAMS.** Each exam will be available for completion for a set period of time. **Exams must be submitted by deadline (as specified in the class schedule below); forgetfulness is NOT an acceptable excuse for failing to complete an exam.** Regardless, if you did not take an exam, for whatever reason, **please contact me as soon as possible.** *No make-up exams will be given without instructor permission. Your average exam score will account for 40% of your overall grade for the course.*

## Writing Assignments

As aforementioned, this course meets the general education writing emphasis requirements. For each of the last three units, there will be a corresponding writing assignment. Each prompt will be based on the material covered in one of the unit's chapters.

Grading will be predominantly based on the quality of your essay as measured by your demonstrated understanding of the material and your command of written language, each assignment will have a given word count (title pages are not included in the page count) and should be formatted using APA guidelines.

Each assignment will be due by **11:55 pm** of the assigned due date (located in the class schedule). Any essays received after this time will be considered late, no excuses. Essays may be submitted up to 96 hours after the deadline for the assignment; you will be penalized 10 points for each day (24-hour period) it is late. *Your average writing assignment score will be worth 20% of your final grade.*

## Chapter Quizzes

For each chapter, you will be assigned at least one quiz on the Canvas course site. All quizzes will be open book unless specified otherwise. The designated "chapter quiz" will be timed, so while you may use your book, it is strongly advised that you read the chapter BEFORE taking this quiz. Once you begin a chapter quiz, you MUST complete it. Other quizzes will require you to read supplemental material, such as news articles or websites; the links for each will be provided for you in the corresponding assignment's instructions. Chapter quizzes will be

accessible for AT LEAST one week.

Each quiz must be submitted by **11:55 pm** of the due date (located in the class schedule below). ***You may submit a quiz within 72 hours AFTER the due date, but you will be docked 15% of the total score for each day it is late. Your average score for the chapter quizzes will account for 15% of your overall grade.***

### **Discussion Board Posts**

Throughout the course, you will be provided with discussion prompts that further address a topic discussed within each chapter. For each discussion board, you must post a response to the prompt and comment on THREE of your fellow classmate's responses. Your posts will be graded for both completion and the quality of the content. Discussion boards will be accessible for AT LEAST one week.

Both posts must be made by **11:55 pm** of the due date (located in the class schedule); any posts made after this time will be considered late. The main response post is due the corresponding **Thursday** & the classmate responses on **Sunday**. Main response posts **submitted** after **11:55 pm** on Thursday are **LATE, however, you may submit it within 72 hours AFTER the due date, but you will be docked 15% of the total score for each day it is late.** Your average score for discussion posts will constitute 20% of your final grade.

### **Chapter Reviews**

As you absorb the material for each chapter, you should simultaneously answer the corresponding chapter review. Chapter reviews are open book and may be completed at your leisure. You will not be limited to a designated time period nor by the number of times you may access the assignment. Chapter reviews will be accessible for AT LEAST one week.

Reviews must be submitted by **11:55 pm** of the due date (located in the class schedule); any posts made after this time will be considered late. ***You may submit a review within 72 hours AFTER the due date, but you will be docked 15% of the total score for each day it is late. Your average score for discussion posts will constitute 25% of your final grade.***

## **Course Learning Outcomes:**

1. Define the science and practice of studying lifespan development.
2. Identify major developmental theorists.
3. Compare and contrast the theories of development.
4. Describe and illustrate the physical, cognitive, and psychosocial domains of development.
5. Analyze the interrelationship of genes and environment and how both impact development.
6. Summarize the process of conception and prenatal development and identify various genetic disorders.
7. Discuss the stages of development including the biological, psychological, social, cultural, and historical indicators that impact each stage.
8. Analyze the aging process and explain what is typical at particular ages and stages.
9. Apply personal "real world" experiences or behaviors to elements of human growth and development.
10. Discuss individual and societal expectations that are associated with the various stages of development.
11. Explain the stages of death, moral considerations associated with dying, and coping strategies of those who are facing end of life challenges.
